



# OREGON WINE, FOOD & BREW FESTIVAL

## 2012 Wine Competition Rules

### ELIGIBILITY

---

The competition is open to all registered wineries of the 2012 Oregon Wine, Food & Brew Festival.

### FEES

---

Fee is \$25 per entry.

Fees paid by check and made out to: OWF&BF.

### ENTRIES

---

Each winery may enter as many wines as they choose in the Red Vinifera, White Vinifera, Dessert and Specialty categories. An official entry must consist two bottles per varietal and the following production details for each entry:

1. Winery
2. Label (if different from winery name)
3. Varietal
4. Vintage
5. Vineyard (if single-vineyard designate)
6. AVA
7. Cases produced
8. Residual Sugar (percentage) (if applicable)
9. Statement attesting that the wine entered is representative of the wine marketed under the same label.

*Note:* All entries assume agreement of award forfeiture in the event of non-compliance. All wines submitted become property of the Oregon Wine, Food & Brew Festival.

### AWARDS

---

The Oregon Wine, Food & Brew Festival will present awards for GOLD, SILVER and BRONZE winners. Two additional medals will be awarded to the wines chosen by the judges as the BEST OF SHOW RED and BEST OF SHOW WHITE. Awards presented prior to opening of Festival.
